- using La Troisième Dimension Products for creating still or animated images, using them (images) for all marketing and commercial purposes including publishing in all available media (i.e: movie advertisement, animation, portfolio).

### Prohibited use includes:

- renting, leasing, selling or sublicensing both modified or original La Troisième Dimension Products content.
